THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility, amending Regulation (EU) No 913/2010 and repealing Regulations (EC) No 680/2007 and (EC) No 67/2010¹, and in particular Article 18(1) thereof,

Whereas:

- (1) Commission Implementing Decision C(2014)1921 of 26 March 2014 established a Multi-Annual Work Programme for financial assistance in the field of Connecting Europe Facility (CEF) Transport sector for the period 2014-2020.
- (2) Commission Implementing Decision C(2017)164 of 20 January 2017 amended that Decision in order notably to provide for a call for proposals for projects of common interest in the transport sector combining grants with private financing, under the general envelope of the CEF, for the following funding objectives: removing bottlenecks and bridging missing links; ensuring sustainable and efficient transport in the long run; and optimising the integration and interconnection of transport modes and enhancing interoperability, safety and security of transport.
- (3) Based on the Multi-Annual Work Programme, the Commission launched such call for proposals on 8 February 2017.
- (4) Following the call for proposals and based on the eligibility, selection and award criteria laid down in the Multi-Annual Work Programme and in the call text, the Commission selected projects of common interest for receiving EU financial assistance. All selected projects meet the required criteria.
- (5) The Commission, acting in accordance with the procedure referred to in Article 25(2) of the CEF Regulation, should decide on the amount of financial assistance to be granted to the projects or parts of projects selected.
- (6) The list of projects of common interest selected by this Decision is in accordance with the opinion of the Committee referred to in Article 25(1) of the CEF Regulation.

HAS DECIDED AS FOLLOWS:

Article 1

The list of projects of common interest in the transport sector selected for receiving EU financial assistance under the Connecting Europe Facility (CEF), the estimated total eligible costs of the actions, the percentage of the financial assistance out of the estimated total eligible costs and the respective maximum amounts of the financial assistance, as laid down in the Annex, are approved.

Article 2
